

WETTIGE DOKUMENTASIE OM N HUWELIK VIR SUID-AFRIKAANSE BURGERS TE VOLTREK

LEGAL DOCUMENTS TO PERFORM A MARRIAGE FOR SOUTH AFRICAN CITIZENS

Die huweliksbevestiger het die volgende wettige dokumentasie nodig om 'n wettige huwelik te voltrek:

The marriage officer requires the following legal documents to perform a legal marriage:

- Drie (3) gekleurde of swart en wit identiteitsgrootte fotos van beide partye.
Three (3) colored or black and white identity document photos of both parties.
- 2 (twee) duidelike ongesertifiseerde afskrifte van beide partye se identiteitsdokumente (OORSPRONKLIKE IDENTITEITSDOKUMENTE MOET GETOON WORD OM SERTIFISERING VAN AFSKRIFTE TE KAN BEVESTIG OP DAG VAN DIE HUWELIK)
2(two) clear uncertified copies of both parties identity documents (ORIGINAL IDENTITY DOCUMENTS TO BE PROVIDED ON DATE OF MARRIAGE TO CONFIRM CERTIFIED COPIES)
- 'n Tydelike identiteitsdokument sal aanvaar word wat nie ouer as 3 MAANDE is nie
A temporarily identity document is acceptable but should not be older than 3 MONTHS
- GEEN geboortesertifikate is enigsins aanvaarbaar nie
NO birth certificates are at all acceptable
- Bewys van residensiele adres (geen posadres sal aanvaar word nie)
Proof of residential address is required (No postal address is acceptable)
- Indien u buite gemeenskap van goedere gaan trou, word die HVK benodig wat op n briefhoof van die betrokke prokureur asook die betrokke prokureur se handtekening en stempel daarop aangebring is.
If getting married out of community of property, the ANC from the attorney on a proper letterhead signed and stamped by the attorney will be required

- Indien u van tevore getroud was en geskei is, benodig ons 2 duidelike afskrifte van die FINALE EGSKEIDINGSBEVEL wat deur die HOF gestempel en geteken is (*GEEN DAGVAARDIGING OF OOREENKOMS SAL AANVAAR WORD NIE*)

If you were previously married and now divorced, we require 2 clear copies of the FINAL DECREE OF DIVORCE signed and stamped by the COURT (*NO SUMMONS OR SETTLEMENT AGREEMENT WILL BE ACCEPTED*)

- Indien u voorheen getroud was en u eggenoot is oorlede, benodig ons 2 duidelike afskrifte van die doodsertifikaat (*OORSPRONKLIKE DOODSERTIFIKAAT SAL GETOON MOET WORD*)

If you were previously married and your spouse is deceased, 2 clear copies of the death certificate will be required (*ORIGINAL DEATH CERTIFICATE MUST BE PROVIDED*)

- Twee (2) Getuies word benodig vir die teken van die huweliksregister.

Two (2) witnesses are required for the signing of the marriage register.

- Die getuies **MOET** Suid-Afrikaanse Burgers wees en bo die ouderdom van 18 jaar wees
The witnesses **MUST** be South Africa Citizens and above 18 years old

- Twee (2) duidelike ongesertifiseerde afskrifte van beide getuies se identiteitsdokumente word benodig (*OORSPRONKLIKE IDENTITEITSDOKUMENTE MOET GETOON WORD OP DAG VAN HUWELIK*)

Two (2) clear uncertified copies of identity documents of both witnesses are required (*ORIGINAL IDENTITY DOCUMENTS HAS TO BE PROVIDED ON DAY OF THE MARRIAGE*)

- Die egpaar ontvang op die dag van die huwelik die oorspronklike huweliksregister asook die handgeskrewe huwelikssertifikaat

The couple will on the day of the marriage receive the original marriage register and also the handwritten marriage certificate

- Dit is die verantwoordelikheid van die huweliksbevestiger om **BINNE 3 DAE** na die huwelik voltrek is by **DEPARTEMENT VAN BINNELANDSE SAKE** te gaan registreer

It is the responsibility of the marriage officer to have the marriage registered within **3 DAYS** after the Marriage was performed at the **DEPARTMENT OF HOME AFFAIRS**
